2024 SCHOLARSHIP APPLICATION GUIDELINES

AgTrust Farm Credit will award **10** graduating seniors from Texas or New Mexico a **\$2,500** scholarship in 2024.

The FFA Chapter or 4-H Club of the 2024 scholarship winners will receive **\$500!**

ELIGIBILITY REQUIREMENTS:

Applicants must be graduating in the spring of 2024, a resident of Texas or New Mexico and submit their application postmarked by March 15, 2024.

The application must include 3 copies of the following:

- 1) Application form
- 2) Résumé containing work experience, community service, organizational involvement and leadership positions
- 3) List of honors, awards and special accomplishments
- 4) Current transcript of grades
- 5) Two letters of recommendation (for example- from a teacher, farmer, rancher, extension agent, elected official)
- 6) AgTrust Farm Credit recognizes that agriculture includes farming, ranching and stewardship of natural resources.
Essay: Two pages maximum
Topic: How has agriculture and natural resources affected your life and what role will they play in your future and career?

AgTrust Farm Credit reserves the right to confirm eligibility requirements. Family members of AgTrust Farm Credit employees and board of directors are not eligible.

Winners will be notified in May and the scholarship will be issued to the college or university to which the student has been accepted. Students not receiving a scholarship will not be notified.

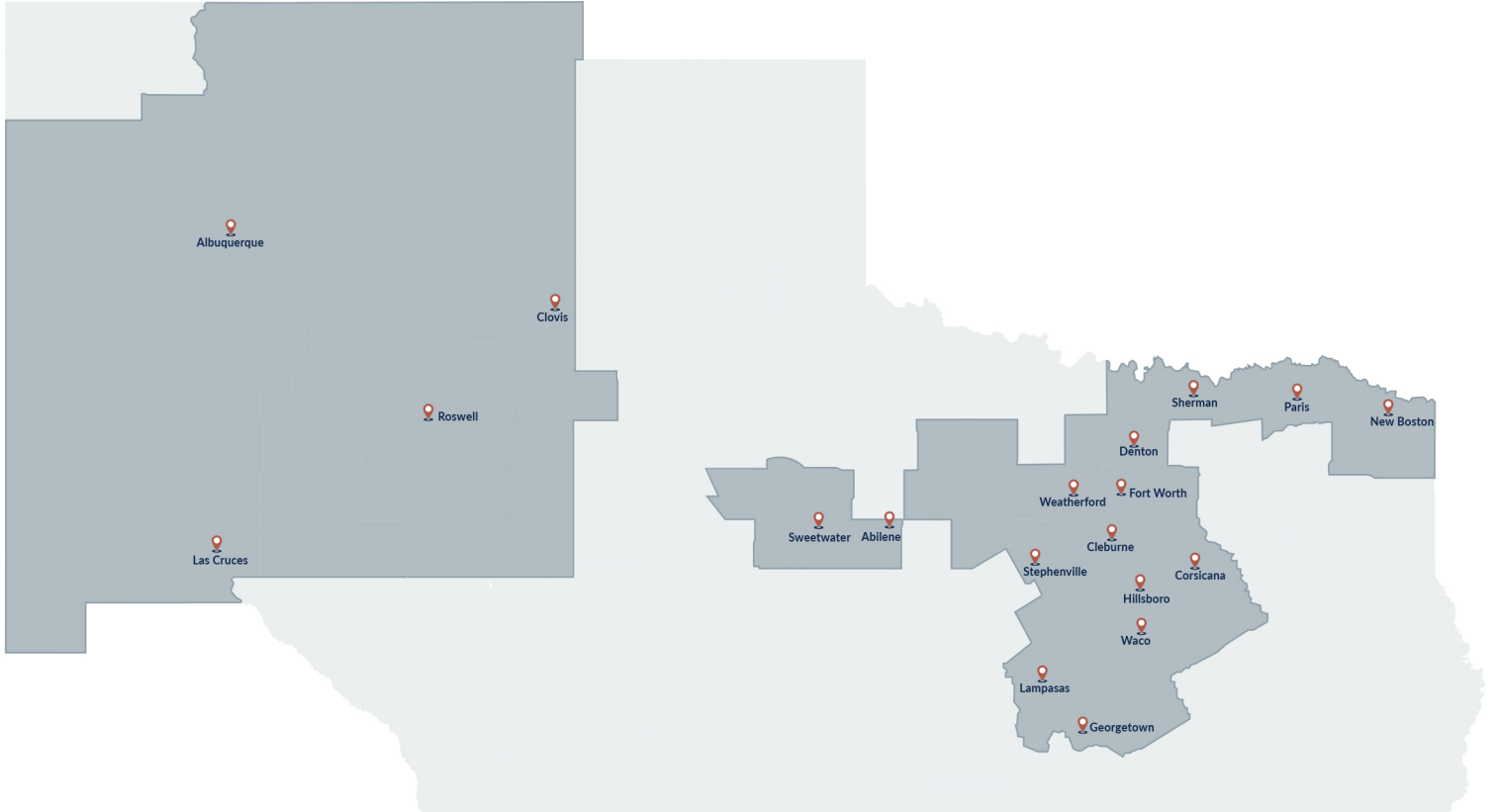
